DECLARATION OF DEREK RICHARDSON IN SUPPORT OF PLAINTIFFS' MOTION FOR SECOND SUPPLEMENTAL PRELIMINARY INJUNCTION

I, Derek Richardson, declare as follows:

1. I am a Principal Investigator in Microsoft Corporation's Digital Crimes Unit ("DCU") Execution at Scale team. I make this declaration in support of Plaintiffs' *Ex Parte* Motion for a Second Supplemental Preliminary Injunction Order. I make this declaration of my own personal knowledge or on information and belief where indicated. If called as a witness, I could and would testify competently to the truth of the matters set forth herein.

2. In my role at Microsoft I assess computer security threats to Microsoft and their impact on Microsoft's business and customers. Among my responsibilities are protecting Microsoft's services from network-based attacks. I also innovate and execute strategies to neutralize cybercrime by partnering with computer technology companies, financial institutions, and government agencies. Before joining Microsoft I worked at Fiveby Solutions, Inc. which provided vendor services to Microsoft's DCU. Prior to that, I obtained my juris doctorate and MBA. I also obtained a graduate certificate in strategic studies and am SANS GIAC certified in Reverse Engineering Malware, Penetration Testing, Advanced Network Forensics, and Windows Forensics. My undergraduate degree is in finance, a field in which I worked for several years in banking and private equity. From 2001 to 2005 I served in the United States Marine Corps infantry, including fighting in the battle of Fallujah of 2004. A copy of my resume is attached to this declaration as **Exhibit 1**.

3. Though I was not involved in the initial investigation that led to the filing of the lawsuit in this matter, after the start of this litigation I received extensive training from Christopher Coy prior to his recent retirement. Mr. Coy provided a declaration in connection with Plaintiffs' Application for An Emergency Temporary Restraining Order and Order To Show Cause Re Preliminary Injunction ("TRO Application"). Through this training I came to understand the use of Cobalt Strike, how to distinguish between legitimate Cobalt Strike and cracked versions thereof, and the continued harm that use of cracked Cobalt Strike has caused and continues to cause Microsoft, its customers, and other third parties.

I. THE INVESTIGATION OF COBALT STRIKE

4. As described in my colleagues' prior declarations submitted in support of the TRO Application and First Supplemental Preliminary Injunction, Microsoft investigators identified operational details about cracked Cobalt Strike: its command and control ("C2") infrastructure, the methods of communication between cracked Cobalt Strike C2s and computers compromised by cracked Cobalt Strike ("infected clients"); how Cobalt Strike is used to deliver additional malware, such as ransomware, to infected clients; and methods used by criminal organizations to evade detection and disruption of their cracked Cobalt operations.

5. DCU Investigators and I observed cracked Cobalt Strike C2 infrastructure in order to understand its operation. We observed infected clients receive instructions from cracked Cobalt Strike C2 servers; these instructions include IP addresses and domains of multiple C2 servers so that the infected client knows how to communicate with C2 infrastructure. In addition to these IP addresses and domains, I can identify additional IP addresses and domains of cracked Cobalt Strike servers.

6. To distinguish between legitimate versions of Cobalt Strike and cracked Cobalt Strike, DCU identifies the watermark of a Cobalt Strike installation. Plaintiff Fortra, the lawful owner of Cobalt Strike, associates watermarks with licenses for use of Cobalt Strike. Plaintiff Fortra provides DCU with watermarks known to be used with cracked (stolen) versions of Cobalt Strike. It is by these watermarks that DCU knows which installations of Cobalt Strike are cracked. DCU operates a crawler that communicates with suspected cracked Cobalt C2 servers. The C2 servers put their watermark within that communication; thus DCU confirms the server is operating a cracked version of Cobalt Strike.

7. On April 6, 2023, Plaintiffs executed the TRO by working with the third party registries and IP hosting companies. By April 8, 2023 many of the C2 domains operated by Defendants had been transferred to Microsoft and many of the C2 IP addresses operated by Defendants were blocked. The Court converted the TRO into the Preliminary Injunction.

8. Subsequently, Plaintiffs sought and obtained a Supplemental Preliminary

Injunction that covered 43 newly discovered domains that Defendants registered as part of their C2 infrastructure. On June 22, 2023, Plaintiffs executed the Supplemental Injunction by working with third party registries; the domains were seized and transferred to Microsoft. I observed a decrease in activity in cracked Cobalt Strike C2 infrastructure.

9. Applying the same investigative methods used in support Plaintiff's TRO and Plaintiff's Supplementary Injunction, DCU identified 15 more domains used as cracked Cobalt Strike C2 servers. Nothing has changed about the operation or infrastructure of cracked Cobalt Strike that would prevent me from using these same methods to identify new C2 domains. These domains are listed in **Exhibit 2** to my declaration and also attached as **Appendix A** to the Proposed Order.

10. Defendants likely use these newly identified C2 domains to execute malware and ransomware attacks. The harm to Microsoft, its customers, and the victims of such attacks remain the same as Mr. Coy described in his declaration.¹

II. DISRUPTING COBALT STRIKE

11. The newly identified C2 domains should be taken offline immediately, without notice, and simultaneously. If Defendants have advanced notice of such actions then Defendants would almost certainly shift their C2s to new domains to evade disruption. Leaving some of the C2 domains active while shutting down others will enable Defendants to 1) register new domains; then 2) cause the remaining C2s to send to infected clients a list of the newly registered domains with instructions that these new domains are new C2s, thus propagating the malicious C2 infrastructure.

12. Based on my experience in internet security matters, the only way to suspend the injury caused by cracked Cobalt Strike domains is to 1) direct the relevant domain registries to transfer the domains to secure servers and accounts controlled by Microsoft; and 2) block any effort by the Defendants to regain control of the domains.

13. Cracked Cobalt Strike infrastructure is global, and so Microsoft is coordinating the relief sought from this Court with analogous legal actions in many other jurisdictions in order to simultaneously disable C2 domains and IP addresses in those locations also. The proposed temporary restraining order is designed to enable coordination to maximize the effectiveness of the collective effort.

14. The aforementioned steps will be executed upon entry of the requested supplemental preliminary injunction, thereby preventing Defendants from accessing their C2 infrastructure, which disables Defendants' ability to communicate with infected clients, thereby ending Defendants' ability to maliciously use cracked Cobalt Strike. This is the only means by which the cracked versions of Cobalt Strike can be disabled and the serious harm to Microsoft and to more than 800,000 computer users can be mitigated and prevented. Once the C2 infrastructure is disabled and Microsoft has control of that infrastructure, Microsoft can assist computer users to remove cracked Cobalt Strike client installations from their devices.

15. Based on observing C2 behavior, I conclude the purpose of these servers is to sustain cracked Cobalt Strike infrastructure and likely to deliver malware to infected clients. Any content or services not associated with cracked Cobalt Strike incidentally interrupted by disruption of C2 domains is likely to minimal; content or services can be restored almost immediately by working with relevant internet infrastructure companies, e.g. hosting providers. I base this on my experience in cybercrime disruption and working with internet infrastructure companies. In previous disruptions any issues were resolved quickly and to all parties' satisfaction. The list of domains in the order requested from this Court has been carefully and conservatively arranged so that the likelihood of these events is minimized.

16. I believe the only way to suspend the injury caused to Microsoft, its customers, and the public is to take the steps described in the Proposed Order Granting Plaintiffs' Ex Parte Motion for a Second Supplemental Preliminary Injunction Order. This relief will significantly hinder Defendants' ability to use cracked Cobalt Strike infrastructure and stop the harmful activities of Defendants.
