The Clerk of the Court, upon receiving such Notice, shall unseal the case and file the foregoing documents on the public docket. Plaintiffs shall be permitted upon filing of such Notice to disclose any such material as deemed necessary to commence its efforts to provide Defendants notice of any further hearings and service of pleadings associated with Plaintiffs' Ex Parte Application for an Emergency Temporary Restraining Order and Order to Show Cause re Preliminary Injunction.
