**PLAINTIFFS' *EX PARTE* MOTION TO SUPPLEMENT THE PRELIMINARY
INJUNCTION ORDER**

Plaintiffs Microsoft Corporation (“Microsoft”), Fortra, LLC (“Fortra”), and Health-ISAC, Inc., (“H-ISAC”) (collectively “Plaintiffs”), by counsel, pursuant to Federal Rule of Civil Procedure 65(b) and (c), the Digital Millennium Copyright Act (17 U.S. § 1201), the Copyright Act (17 U.S.C. §§ 101 *et seq.*), Computer Fraud and Abuse Act, 18 U.S.C. § 1030, Trademark Infringement under the Lanham Act, 15 U.S.C. § 1114 *et seq.*, False Designation of Origin under the Lanham Act, 15 U.S.C. § 1125(a), Trademark Dilution under the Lanham Act, 15 U.S.C. § 1125(c), the Racketeer Influenced and Corrupt Organizations Act (18 U.S.C. § 1962), Common Law Trespass to Chattels, Unjust Enrichment, and Conversion, respectfully moves the Court for an order to supplement the Preliminary Injunction Order.

As discussed in Plaintiffs’ brief in support of this Ex Parte Motion Supplement the Preliminary Injunction Order contemporaneously filed and for the same reasons set forth in Plaintiffs’ Application for an Ex Parte Temporary Restraining Order and Order to Show Cause re Preliminary Injunction (“TRO Application”), Plaintiffs request an order allowing them to supplement the list of domains filed on March 30, 2023, with the new domains being used by Defendants set forth in **Appendix A** to the Proposed Order filed concurrently with this Motion.

As set forth more fully in Plaintiffs’ brief, recent evidence shows that Defendants are again rebuilding the cracked Cobalt Strike infrastructure in defiance of the Court’s authority, by bringing online new domains, which Defendants are using the same illegal manner and for the same illegal purposes described in the TRO Application.

The requested relief is necessary to halt the cracked Cobalt Strike operation that is causing irreparable injury to Plaintiffs and their customers. Plaintiffs respectfully request that the Court grant this Motion.

**BRIEF IN SUPPORT OF PLAINTIFFS' *EX PARTE* MOTION TO SUPPLEMENT THE
PRELIMINARY INJUNCTION ORDER**

Plaintiffs Microsoft Corporation (“Microsoft”), Fortra, LLC (“Fortra”), and Health-ISAC, Inc., (“H-ISAC”) seek an *Ex Parte* Supplemental Preliminary Injunction Order to address Defendants’ continuing efforts to rebuild the Cracked Cobalt Strike command and control infrastructure and continue their illegal activities in open defiance of this Court’s Preliminary Injunction Order. Plaintiffs express their appreciation for the continued attention of the Court to this ongoing cyber-security matter.

Plaintiffs incorporate by reference herein the arguments and evidence set forth in their Brief In Support Of Plaintiffs’ Application for an *Ex Parte* Temporary Restraining Order and Order To Show Cause Re Preliminary Injunction (“TRO Application”). Dkt. No. 3. As discussed in

Plaintiffs' TRO Application, the domains used in cracked Cobalt Strike's command and control infrastructure are critical to the operation conducted by John Does 1-16 (collectively "Defendants") whereby Defendants have abused the legitimate security testing tool called Cobalt Strike for an illegal purpose that causes extreme and continued irreparable harm to Plaintiffs, their customers and members, and the general public. The most effective way to disrupting Defendants' operation is to disable the domains used by Defendants in connection with cracked Cobalt Strike.

I. BACKGROUND

On March 31, 2023, the Court granted an Emergency *Ex Parte* Temporary Restraining Order ("TRO") tailored to halt the illegal activities and the growth of Defendants' cracked Cobalt Strike Operation. Dkt. No. 13. Defendants' use cracked versions of Cobalt Strike to deploy malware and ransomware onto victims' computers, allowing Defendants to infect victims' computers, hijack the victims' operating systems, and steal users' sensitive data. Defendants cause great harm to Plaintiffs by damaging the products and services they provide to their customers. Further, by exploiting Plaintiffs' famous and highly-regarded trademarks, products, and services to disguise and further its criminal conduct, Defendants cause Plaintiffs irreparable reputational and other harms for which no monetary recourse is available.

As explained in Plaintiffs' TRO Application, Defendants conduct their illegal operations by using an online command and control infrastructure consisting of a set of websites and domains. Dkt. No. 3-1 at 6. These domains are used both to break into computers and networks of the organizations that Defendants targets, perform reconnaissance of those networks, and, ultimately, exfiltrate sensitive information from them. To disable this command and control infrastructure, this Court ordered that these Defendants-controlled domains, listed in Appendix A filed on March 30, 2023, be redirected to secure Microsoft servers. Dkt. No. 13. On April 19, 2023, the Court

converted the TRO into a Preliminary Injunction. Dkt. No. 20. On May 15, 2023, Plaintiffs submitted a letter motion seeking leaving to take Doe discovery designed and aimed at investigating the Defendants and their identifies. Dkt. No. 21. To date, the Doe discovery motion remains pending.

Executing the Court's Temporary Restraining Order and Preliminary Injunction Order, Plaintiffs cut communications between Defendants' existing command and control infrastructure and the victim computers and networks that Defendants attacked and from which Defendants had been stealing information. Declaration of Jason Lyons In Support Of Plaintiffs' Motion to Supplement Preliminary Injunction Order ("Lyons Decl.") ¶ 6. This effectively stymied Defendants' effort to exploit the computers and networks they had targeted or compromised.

However, Defendants, who are evidently resourceful and well-funded, continue to try to maintain and reestablish new command and control domains and other command and control infrastructure so that they can continue their illegal activities. Indeed, this probability was foreseen by the Court in issuing its TRO. And as foreseen, following the execution of the TRO and Preliminary Injunction, Defendants openly defied this Court and started to rebuild their command and control infrastructure by adding 43 new domains to the cracked Cobalt Strike command and control infrastructure. *Id.* ¶ 7. Consequently, Plaintiffs ask the Court to allow it to redirect the new domains associated with the cracked Cobalt Strike operation to Microsoft secure servers. *Id.* ¶ 11. This will disrupt Defendants' recent illegal activity. A list of the new domains used by Defendants is provided in Appendix A to the Proposed Order filed concurrently with this brief.

II. ARGUMENT

A. There Is Good Cause to Supplement the Preliminary Injunction Order

Plaintiffs seek to supplement the Preliminary Injunction Order by including the domains in Appendix A to the Proposed Order submitted with this motion to the prior list of domains transferred to Microsoft pursuant to the Court's prior injunctive relief. This will allow Plaintiffs to disrupt Defendants more recent illegal activity. Such supplemental relief has been granted in prior cases when defendants began using new domains after the court granted a temporary restraining order. *See, e.g., Microsoft Corp. v. John Does 1-8*, Case No. 1:14-cv-00811-LOG-TCB (E.D. Va. 2014) (O'Grady, J.) at Dkt. No. 32 (supplemental injunctive relief aimed at disabling the "Shylock" botnet); *Microsoft Corp. v. John Does 1-2*, Case No. 1:19-cv-00716-ABJ (Berkman Jackson, J.) at Dkt. No. 21 (granting supplemental injunction to seize additional domains associated with the Phosphorous command and control infrastructure). Here, absent the requested relief, irreparable harm will continue to Plaintiffs and their customers, for the reasons detailed in Plaintiffs' prior submissions. Plaintiffs are likely to succeed on the merits, because the domains at issue in this motion are used for the same unlawful purposes and in the same unlawful manner set forth in Plaintiffs' previous TRO Application. Lyons Decl. ¶ 9. Thus, pursuant to Federal Rule of Civil Procedure 65, disabling the additional 11 domains at issue is necessary to prevent harm to Plaintiffs and their customers. With respect to supplementing the Preliminary Injunction Order, *ex parte* relief is essential. If notice is given prior to issuance of the requested relief, it is likely that Defendants will be able to quickly mount an alternate command and control structure because Defendants have the technical sophistication and ability to move their malicious infrastructure. Lyons Decl. ¶¶ 12-15. Thus, providing notice of the requested *ex parte* relief will undoubtedly facilitate efforts by Defendants to continue to operate. Rule 65 of the Federal Rules of Civil

Procedure permits *ex parte* injunctive relief where the moving party sets forth facts that show an immediate and irreparable injury and why notice should not be required. Fed. R. Civ. P. 65(b)(1); *see Granny Goose Foods, Inc. v. Brotherhood of Teamsters & Auto Truck Drivers, Local No. 70*, 415 U.S. 423, 438–39 (1974) (“Ex parte temporary restraining orders are no doubt necessary in certain circumstances....”). It is well established that *ex parte* relief is appropriate under circumstances such as here, where notice would render the requested relief ineffective. *See, e.g., AT&T Broadband v. Tech Commc’ns, Inc.*, 381 F.3d 1309, 1319-20 (11th Cir. 2004) (affirming *ex parte* search and seizure order to seize contraband technical equipment, given evidence that in the past defendants and persons similarly situated had secreted evidence once notice given); *In re Vuitton Et Fils S.A.*, 606 F.2d 1, 4-5 (2d Cir. 1979) (holding that notice prior to issuing TRO was not necessary where notice would “serve only to render fruitless further prosecution of the action”; prior experience taught that once one member of the counterfeiting enterprise received notice, contraband would be transferred to another unknown counterfeiter, perpetuating the harm and rendering judicial efforts pointless); *Little Tor Auto Ctr. v. Exxon Co., USA*, 822 F. Supp. 141, 143 (S.D.N.Y. 1993) (*ex parte* TRO appropriate where contraband “may be destroyed as soon as notice is given”).

As before in this matter, immediately upon execution of the Supplemental Preliminary Injunction and disabling of the additional domains addressed in the attached proposed order, Plaintiffs will provide robust notice to the Defendants, consistent with the alternative service methods already authorized by this Court. Dkt. No. 13. Plaintiffs will provide Defendants the documents associated with this motion and the Court’s order, by sending them to all of Defendants’ contact information associated with the subject domains, thus providing notice and an opportunity to appear and contest the requested relief, if Defendants so choose.

III. CONCLUSION

For the reasons set forth in this brief, the Lyons Declaration submitted with this brief and based on the evidence submitted with the prior Application for TRO and Preliminary Injunction, Plaintiffs respectfully request that the Court grant Plaintiffs' Motion To Supplement the Preliminary Injunction Order.

**DECLARATION OF JASON B. LYONS IN SUPPORT OF APPLICATION FOR AN
EMERGENCY *EX PARTE* TEMPORARY RESTRAINING
ORDER AND ORDER TO SHOW CAUSE RE PRELIMINARY INJUNCTION**

I, Jason B. Lyons, declare as follows:

1. I am a Principal Manager of Investigations in Microsoft Corporation's Digital Crimes Unit ("DCU") Ransomware Team. I make this declaration in support of Plaintiffs' *Ex Parte* Motion to Supplement the Preliminary Injunction Order. I make this declaration of my own personal knowledge or on information and belief where indicated. If called as a witness, I could and would testify competently to the truth of the matters set forth herein.

2. In my role at Microsoft, I assess technological security threats to Microsoft and the impact of such threats on Microsoft's business and customers. Among my responsibilities are protecting Microsoft's online service assets from network-based attacks. I also participate in the investigation of malware and participate in court-authorized countermeasures to neutralize and disrupt malware. For example, I have personally investigated and assisted in the court-authorized takedown of several families of malware or botnets while at Microsoft, including the malware families and botnets known as Ramnit, ZeroAccess, Dorkbot, and Necurs. Before joining Microsoft, I worked for Xerox as the Manager of Xerox's Cyber Intelligence Response Team. I also worked for Affiliated Computer Services ("ACS") prior to Xerox's acquisition of ACS. While at ACS, I provided in-court testimony in connection with a temporary restraining order application concerning misappropriation of ACS's intellectual property. Prior to entering the private sector, from 1998 to 2005, I served as a Counterintelligence Special Agent in the United States Army. My duties as a Counterintelligence Special Agent included investigating and combating cyber-attacks against the United States. I obtained certifications in counterintelligence, digital forensics, computer crime investigations, and digital media collection from the United States Department of Defense.

3. In connection with Plaintiffs' Application for An Emergency Temporary Restraining Order and Order To Show Cause Re Preliminary Injunction ("TRO Application"), I was involved in investigating the structure and function of Cobalt Strike as well as the activities carried out through the use of cracked versions of Cobalt Strike, and an assessment of the impact on Microsoft's business and on users of the Internet. Misuse of Cobalt Strike has caused, and

continues to cause, extreme damage to Microsoft and other parties, which if allowed to continue, will be compounded as the case proceeds.

I. THE INVESTIGATION OF COBALT STRIKE

4. As described in my previous declaration submitted in support of the TRO Application, Microsoft investigators and I have been able to identify operational details about cracked versions of Cobalt Strike, including its C2 infrastructure, the methods of communication among infected computers, how Cobalt Strike is used to transmit threats to innocent computers, and the criminal enterprise's mechanisms to evade detection and attempts to disrupt its operation. access to infected machines and acting as a gateway malware dropper to deploy additional ransomware.

5. Additionally, my investigation involved obtaining copies of cracked Cobalt Strike and examining them. As described in my prior declaration, Microsoft investigators and I analyzed approximately 50,000 unique samples of cracked Cobalt Strike. Microsoft investigators and I purposely deployed cracked versions of Cobalt Strike to investigator-controlled computers, and we observed cracked Cobalt Strike C2 infrastructure, in order to understand its operation. This allowed us to monitor and analyze the Cobalt Strike infrastructure in order to understand its lifecycle. I participated in and reviewed these investigative techniques. We also observed the infected computers that connect to and receive instructions from C2 servers associated with cracked versions of Cobalt Strike; and through this method, we were able to identify IP addresses and domains of the C2 servers used to control cracked versions of Cobalt Strike. Based on my examination of aforementioned identified IP addresses and domains, I was able to ascertain particular technical features and behaviors associated with those IP addresses and domains, which further allowed me to confirm that new IP addresses and domains are associated with cracked versions of Cobalt Strike. This verification process has enabled me to accurately identify C2 servers associated with cracked versions of Cobalt Strike that should be disabled.

6. On April 6, 2023, Plaintiffs executed the TRO by working with the third-party

registries and IP hosting companies. By April 8, 2023, much of the infrastructure operated by Defendants had been transferred to Microsoft (with respect to domains) or traffic blocked (with respect to IP addresses). Subsequently, I observed a decrease in activity attributable to the cracked Cobalt Strike command and control infrastructure. However, because of the technical sophistication of Defendants, Microsoft investigators and I have observed that Defendants have tried to reestablish new command and control domains and other command and control infrastructure so that they can continue their illegal activities. To investigate and identify these new command and control domains, Microsoft investigators and used the same investigative methods described in connection with my previous declaration in support of Plaintiffs' TRO Application.¹

7. Since the Preliminary Injunction Order, I have identified 43 additional domains that Defendants have registered in connection with their cracked Cobalt Strike operation. These domains are listed in **Exhibit 1** to my declaration and also attached as **Appendix A** to the Proposed Order.

8. Similar to my previous investigative efforts, I identified these additional domains based on the watermarks provided by Plaintiff Fortra. Once the Microsoft investigators and I received the additional watermarks from Fortra, I evaluated the watermarks and deployed the same previously-described and used crawler to identify cracked versions of Cobalt Strike.

9. Nothing has changed about the operation or infrastructure of cracked Cobalt Strike that would prevent me from using these same methodologies to identify the new domains used by Defendants to rebuild or reestablish the command and control infrastructure. Additionally, based on my investigation, Defendants utilize these new domains in the same way and to carry out the same illegal acts. Accordingly, it is likely that Defendants will use these newly identified domains in connection with utilizing cracked Cobalt Strike to carryout future malware and ransomware attacks. The potential harm to Microsoft, its customers, and the victims of such attacks remain the

same as what I previously described in my declaration.²

II. DISRUPTING COBALT STRIKE

10. Given the specific architecture of the cracked versions of Cobalt Strike, I believe that if provided advance notice that the command and control IP addresses and domains were to be disabled, the Defendants would take measures to keep cracked versions of Cobalt Strike alive by migrating to new IP addresses and domains. As discussed, Defendants' activities are designed to evade detection by changing the IP addresses and domains of command and control servers over time. Therefore, a piecemeal approach to disconnecting the IP addresses and domains will fail. If less than all of the command and control servers are directed to be taken offline immediately and simultaneously, the Defendants will be able to migrate to new, unidentified command and control servers.

11. Based on my experience involving Internet security matters, I believe that the only way to suspend the injury caused by Cobalt Strike domains is to:

- a. direct the relevant domain registries to transfer the domains to secure servers and accounts controlled by Microsoft; and
- b. block any effort by the Defendants to regain control of the domains.

12. It is important that the requested actions be closely coordinated, such that the malicious domains, in various locations, are directed by the Court to be turned off immediately upon receipt of any order issued by the Court and in coordination with other efforts, such that these domains are turned off simultaneously. Any delay in disabling the IP addresses and domains would warn the operators of this action and immediately relocate the command and control servers to unidentified servers/locations. In particular, because the cracked Cobalt Strike command and control infrastructure is globally distributed, this relief sought from the Court is being coordinated with legal efforts in many other jurisdictions. Microsoft's field team across the world are taking analogous steps under the legal authority and legal systems of a number of other countries, to

simultaneously disable command and control IP addresses and domains in those jurisdictions. The proposed temporary restraining order is framed in a manner that enables coordinated efforts that will maximize the effectiveness of the effort.

13. In the aggregate, the foregoing steps, which will be carried out upon entry of the requested supplemental preliminary injunction, will prevent the Defendants from accessing their command and control infrastructure, will cut off Defendants' ability to communicate with the infected victim computers, and will effectively disable the operation of the cracked versions of Cobalt Strike. This is the only means by which the cracked versions of Cobalt Strike can be disabled and the serious harm to Microsoft and to more than 800, 000 computer users can be mitigated and prevented. Once the command and control infrastructure is disabled, and Microsoft has control of that infrastructure, this will enable Microsoft to assist users impacted by the cracked versions of Cobalt Strike in cleaning their systems.


14. I have recently investigated the command and control IP addresses and domains in the context of the malware. Based on observing the IP addresses and domains, I conclude that their purpose is to support and propagate the cracked versions of Cobalt Strike and the further malware delivered by Defendants, as described above, and that they further malicious activity. If there is content not associated with cracked versions of Cobalt Strike that is incidentally contained on the servers at these IP addresses, based on my experience as a technologist generally, my work involving Internet security matters specifically, and my prior experience carrying out court-authorized cybercrime disruption efforts, I am aware that by working with the hosting providers, the infrastructure associated with the Defendants can be specifically disabled, without impacting other users. For example, in prior matters, working with the hosting providers in similar matters, to execute court orders, it has always been possible to identify and disable particular virtual machines specifically associated with Defendants and a given IP address or to block traffic to and/or from particular ports being used by Defendants. The court order requested in this matter is specifically tailored to only impact such facilities utilized by Defendants.

15. I believe that the only way to suspend the injury caused to Microsoft, its consumers,

and the public, is to take the steps described in the Proposed Order Granting Plaintiffs' Ex Parte Motion to Supplement the Preliminary Injunction. This relief will significantly hinder the Defendants' ability to use the cracked Cobalt Strike infrastructure and stop the harmful activities of the Defendants.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct to the best of my knowledge.

**[PROPOSED] ORDER GRANTING PLAINTIFFS' *EX PARTE* MOTION TO
SUPPLEMENT THE PRELIMINARY INJUNCTION**

The Court, having considered the pleadings and declaration in support of Plaintiffs Microsoft Corp. (“Microsoft”), Fortra LLC (“Fortra”), and Health-ISAC, Inc. (“Health-ISAC”) (collectively, “Plaintiffs”) Motion to Supplement the Preliminary Injunction Order, hereby orders that the terms of the Preliminary Injunction Order (“Preliminary Injunction Order”), Dkt. No. 20, shall apply to the additional domains set forth in Appendix A to this order. As set forth below, Defendants have violated the Preliminary Injunction.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

Having reviewed the papers, declarations, exhibits, and memorandum filed in support of Plaintiffs’ Motion to Supplement the Preliminary Injunction Order, the Court hereby makes the following findings of fact and conclusions of law:

1. The Defendants were served with notice of the TRO and Preliminary Injunction via the alternative service methods previously authorized by this Court.
2. After receiving notice of the TRO and Preliminary Injunction, the Defendants have continued to engage in the conduct enjoined by the Preliminary Injunction Order, and therefore continue to violate the Preliminary Injunction Order. In particular, using new domains, Defendants have intentionally and without authorization, continued and attempted to access and send malicious software, code, and instructions to protected computers, operating systems, and networks of Plaintiffs and their customers, attacking such computers, systems and networks, and exfiltrating information from those computers, systems and networks..
3. There is good cause to believe that Defendants are likely to continue the foregoing conduct and to engage in the illegal conduct and purposes enjoined by the Preliminary Injunction Order, unless further relief is ordered to expeditiously prevent Defendants from maintaining the domains for such prohibited and unlawful purposes.
4. There is good cause to believe that, unless further relief is ordered to expeditiously prevent Defendants from maintaining the domains for purposes enjoined by the Preliminary Injunction Order, immediate and irreparable harm will result to Plaintiffs, their customers, and to the public, from the Defendants’ ongoing violations.

5. Therefore, in accordance with Fed. R. Civ. P. 65(b), 15 U.S.C. § 1116(a) and 28 U.S.C. § 1651(a) and the Court's inherent equitable authority, good cause and the interests of justice require that this Order be Granted.

SUPPLEMENTAL PRELIMINARY INJUNCTION

IT IS THEREFORE ORDERED that, the terms of the Preliminary Injunction Order shall be supplemented and shall be enforced against Defendants, Defendants' representatives, and persons who are in active concert or participation with Defendants and pursuant to the All Writs Act, with respect to any currently registered Internet domain set forth in **Appendix A**, the domain registries shall take the following actions:

A. Within three (3) business days of receipt of this Order, shall unlock and change the registrar of record for the domain to MarkMonitor or such other registrar specified by Microsoft. To the extent the registrar of record does not assist in changing the registrar of record for the domain under its control, the domain registry for the domain, or its administrators, including backend registry operators or administrators, within five (5) business days of receipt of this Order, shall change, or assist in changing, the registrar of record for the domain to MarkMonitor or such other registrar specified by Microsoft. The purpose of this paragraph is to ensure that Microsoft has control over the hosting and administration of the domain in its registrar account at MarkMonitor or such other registrar specified by Microsoft. Microsoft shall provide to the domain registry or registrar of record any requested registrar information or account details necessary to effectuate the foregoing.

B. The domain shall be made active and shall resolve in the manner set forth in this order, or as otherwise specified by Microsoft, upon taking control of the domain;

C. The domain registries shall take reasonable steps to work with Microsoft to ensure the transfer of the domain and to ensure that Defendants cannot use it to make unauthorized access to computers, infect computers, compromise computers and computer networks, monitor the owners and users of computers and computer networks, steal information from them or engage in any other activities prohibited by this Order;

D. The WHOIS registrant, administrative, billing and technical contact and identifying information should be the following, or other information as may be specified by Microsoft:

E. Prevent transfer, modification or deletion of the domain by Defendants and prevent transfer or control of the domain to the account of any party other than Microsoft;

F. Take all steps required to propagate to the foregoing changes through the Domain Name System (“DNS”), including domain registrars.

IT IS FURTHER ORDERED that copies of this Order may be served by any means authorized by law, including any one or combination of (1) personal delivery upon Defendants who provided accurate contact information in the U.S., if any; (2) personal delivery through the Hague Convention on Service Abroad or similar treaties upon defendants who provided accurate contact information in foreign countries that are signatory to such treaties, if any, (3) transmission by email, facsimile, mail and/or personal delivery to the contact information provided by Defendants to their hosting companies and as agreed to by Defendants in their hosting agreements, (4) publishing notice on a publicly available Internet website and/or in newspapers in the communities where Defendants are believed to reside.
